General Policies:

Tuition is due monthly the 1st class of each month. Checks should be made out to 'Dancing For Joy'. A late fee of \$10 will be issued to accounts if tuition is not paid by the 15th of each month. If Dancing For Joy is closed on the 15th, then payment is due the first business day thereafter. You may mail or bring checks to: 4073Hannegan Rd. Suite #F at our studio. Tuition is due in full during recital months (December and June) for everyone. DFJ considers extra dress rehearsal time as the 4th class in those months. Individuals in non-performing classes, may make up one class during the session. If you pay for 3 or more months of dance instruction in advance you will receive a 5% discount on those classes. There is no pro-rating for joining late, or for missed classes, with the exception of new students joining for the first time. Students are responsible to make up missed classes in another age appropriate class. A charge of \$20 will be added onto your account if we receive a check with Non-Sufficient funds.

A \$20 Non-Refundable Registration Fee must be included with this Registration Form to secure a spot for classes. This fee is due annually for everyone when you register for dance classes for the next school year.

Classes may be cancelled if there are 4 or less students enrolled. Classes will be capped at 12-15 students (depending on style and age). The Dancing For Joy Studio will be closed for Mid-Winter & Spring Break, Labor Day, Memorial Day, Thanksgiving, and Christmas Break. Missed classes for Labor Day, Memorial Day, and Thanksgiving may be made up during that session. DFJ will hold classes during all other holidays during the session. All classes that are cancelled due to snow can be made up in another age appropriate class. All students are required to adhere to the DFJ dress code noted in the brochure. DFJ is not responsible for providing the necessary shoes or clothes for dance class. Personal property is the sole responsibility of each person/student that enters the Studio. Costume fees may be required for performances.

AGREEMENT, RELEASE AND WAIVER OF LIABILITY

In consideration of being permitted to participate in dance lessons, instructions and performances presented by DANCING FOR JOY, L.L.C., on behalf of myself or a minor child or ward, heir, next of kin, or personal representative, I acknowledge, understand and declare as follows.

To the best of my knowledge, my minor child is in good physical condition and has no disease or injury that would be aggravated by participating in activities related to the dance classes. If I am the participant, I am in good physical condition and have no disease or injury that would be aggravated by participating in activities related to the dance classes.

Participating in dance classes may involve RISK OF INJURY, including, but not limited to, muscle or other soft tissue strains, sprains and tears, broken bones and severe injuries such as paralysis or even death. I am fully aware of the inherent risks involved in dance activities and the possibility of injury from participating in such activities.

I ASSUME ALL RISKS ASSOCIATED WITH DANCE ACTIVITIES AND WAIVE, DISCHARGE, HOLD HARMLESS, INDEMNIFY AND COVENANT NOT TO SUE Dancing For Joy, L.L.C. and its managers and members FROM ANY AND ALL LIABILITY FOR INJURY, INCLUDING DEATH, LOSS OR DAMAGE TO PERSON OR PROPERTY in connection with participation in dance lessons or performances or any activity associated with dance lessons or performances, including transportation to or from any lesson, performance or other related activity.

I specifically acknowledge that Dancing For Joy, L.L.C. shall bear no responsibility for my child when he or she is left unattended outside the scheduled times for any Dancing For Joy, L.L.C. activity, whether from being dropped off early, picked up late or any other reason.

I expressly agree that this Release, Waiver and Indemnity Agreement is intended to be as broad and inclusive as permitted by the laws of the State of Washington, and if any portion of the Agreement is held to be invalid, it is agreed that the remaining portions shall nonetheless continue in full force and effect.

I fully understand that the members of the staff of Dancing For Joy, L.L.C. are not physicians or medical practitioners of any kind. With this in mind, I hereby authorize Dancing For Joy, L.L.C. to render first aid to me or my child in the event of injury or illness, and if deemed necessary, to call an ambulance for which I will be financially responsible, or to arrange other transportation of a sick or injured participant. I agree to provide health insurance for myself or my child or guarantee payment of any medical expenses incurred as a result of training, performing or participation in activities with Dancing For Joy, L.L.C.

I ACKNOWLEDGE THAT I HAVE READ THIS FORM IN ITS ENTIRETY AND HAVE PROVIDED TRUTHFUL INFORMATION. I FURTHER ACKNOWLEDGE THAT I HAVE SIGNED THIS AGREEMENT, RELEASE AND WAIVER OF LIABILITY FREELY AND VOLUNTARILY.
